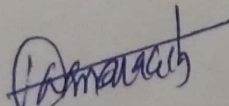
Subject: Meeting of Internal Quality Assurance Cell (IQAC)

All members are earnestly requested to attend the meeting punctually.

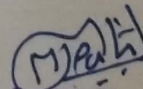

Minutes of the Meeting

The meeting of the Internal Quality Assurance Cell (IQAC) of Dev-Ghaisas-Keer Arts, Commerce and Science Senior College, under Bharat Shikshan Mandal, was held on 29 May 2026 in the Principal's Office.
